October 11, 2017

Call to order at 6:45 pm

Special Guest-Ms. Thonnings –English Dept:

Ms. Thonnings has taken over the Cross Disciplinary/Cross Generational Reading Seminar-This is a spring program (currently set for March 15th, trying to move to March 22nd due to Music Dept Assessments) that encourages students, teachers, parents, and community members to read a selected book. The past two years this has been a science-related book and she is very excited to move into the arts with this year's book- "Symphony for the City of the Dead" which is about the composer Shostakovich, a Russian composer during WWII in Russia. This is a book written for teens with an art approach to history. Ms. Thonnings has been in talks with Kathy (who did her graduate thesis on Shostakovich) and is looking forward to pairing with the Music Department for this program. The BSO is performing his 5th symphony in June- perhaps can get tickets for door prizes and/or take a field trip to a rehearsal. Possible for our students to perform? Possible for Kathy to get her band director as a speaker? Possible for community band musicians to attend the event as well and be part of discussions? 150 books have been ordered, will be given out in Jan. June 7-10th is BSO Concert. Boosters pay for bus? (See attached book description.)

Music Director's Report (Kathy Krawczyk):
