President's Report (Stephanie Soper):

Welcome. No new faces. Only board plus Judy Bailey and Carrie Smith in attendance. Should we use a Remind App? Inserts in concert programs to explain Boosters? How do we get people in? We need to have a new board in place for next years as all but one on current board are parents of seniors.

Instrumental Music Director's Report (Kathy Krawczyk):

Good beginning to year. There are several mixed classes (examples trumpet in a strings class, freshman strings with 3 senior string players) and large class sizes- need to be creative...but making it work.

Kathy would like to purchase some filing cabinets to better organize music. Carrie suggested checking with the BCPS warehouse.

Music office purchased 2 new violins and a flute.

New drum heads have been purchased for timpani-will need to pay to have them seated-more info to come.

Tri-M:

Induction will be later in the year with all of the honor societies.

TriM had officers meeting- would like to move forward on a service project.

Performance Wear:

There is still lots to come in. ½ of band is complete. Need a class list to deal with the chorusand decide on timeline.

Discussion about giving the music t-shirts to all incoming freshman. 72 shirt min. \$6.50. down to \$5.09 with an order of 145. Or we could just charge \$5/short and then supplement. If we give the t-shirts- do we just do that for band (required for pep rally) or for orchestra as well?
